



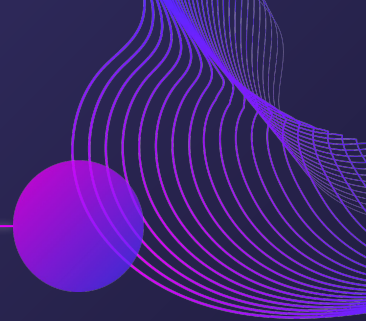

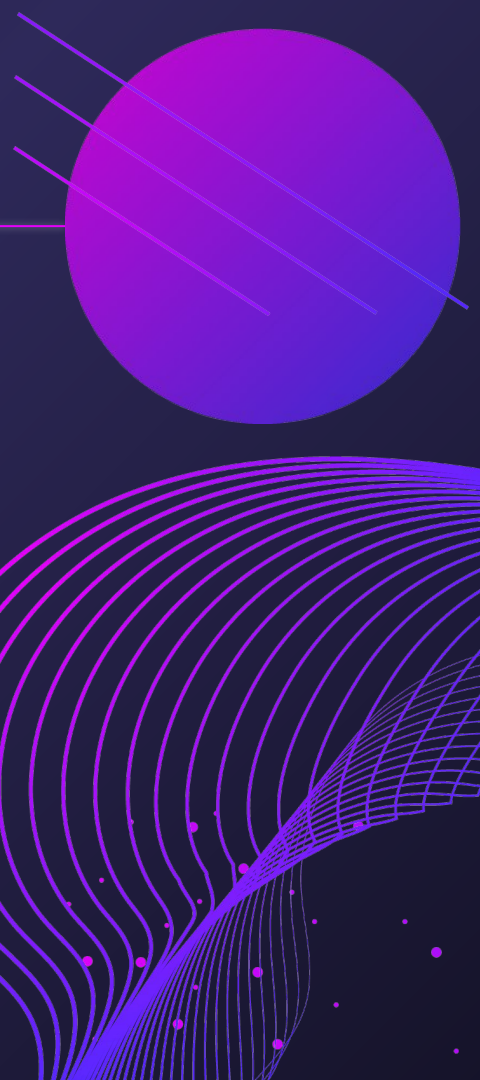

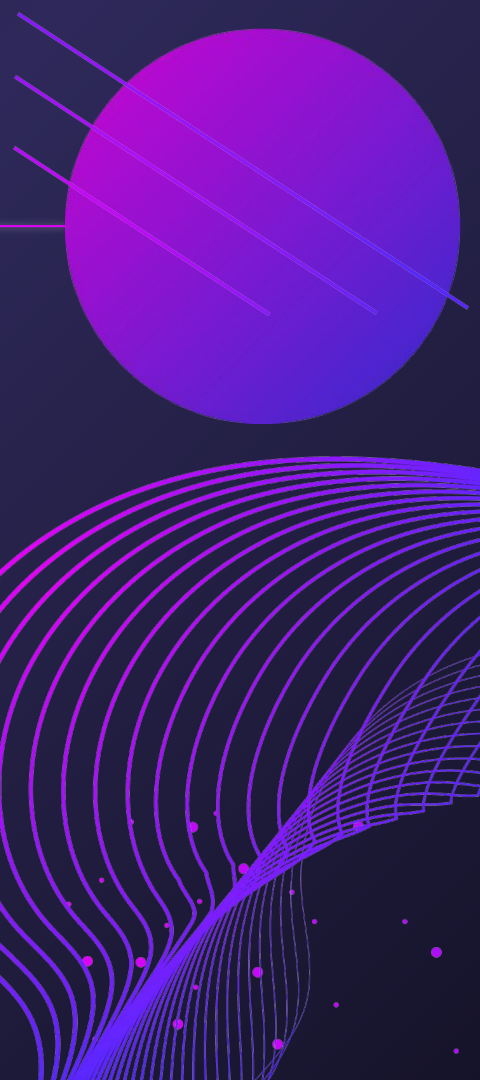


VISION

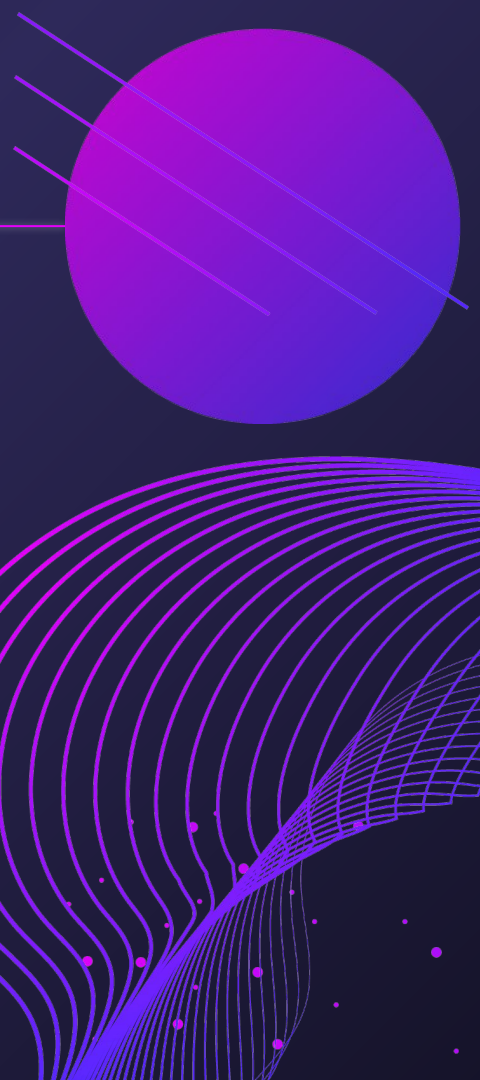


MISSION

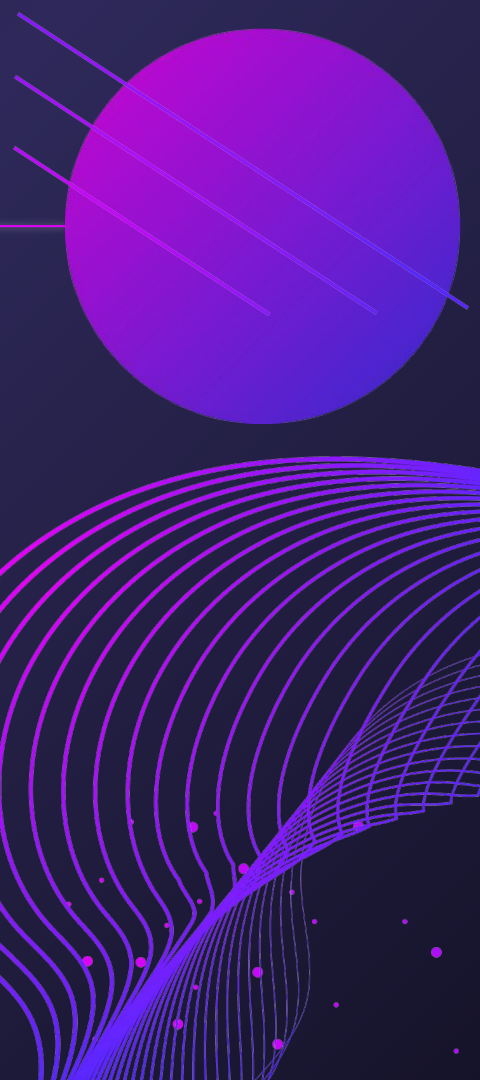


MISSION

Not just stopping at the role of an intermediary, STC is committed to providing attractive opportunities for both the investor community and businesses, fostering sustainable development and creating a win-win model.

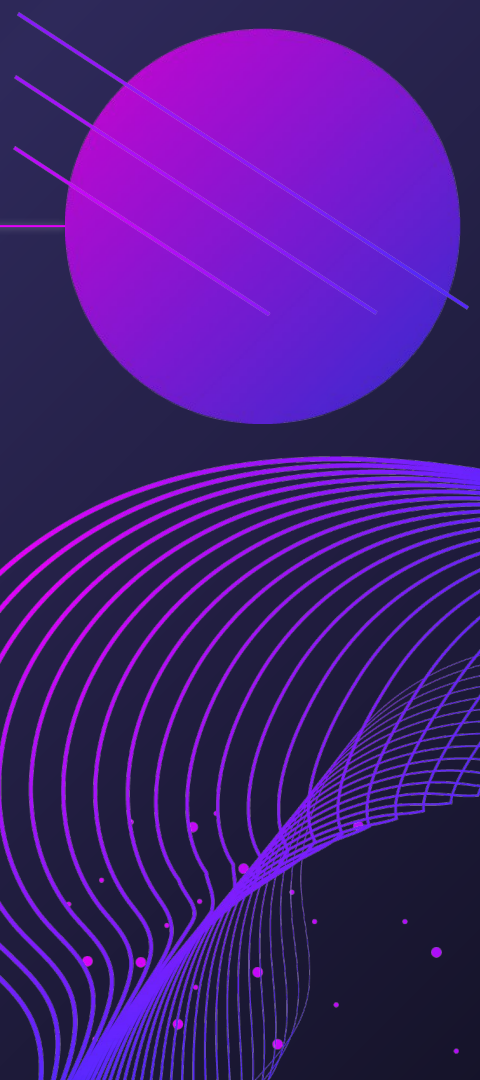
